Subject: Inviting to the Public Consultation of the Environmental Impact Assessment on the Thilawa Special Economic Zone Development Project Zone A (Phase 1 & 2 under operation plus Phase 3 extension) and Zone B for Industrial Area extension

The Thilawa Special Economic Zone Development Projects (Zone A & Zone B) which are now being planned and currently the environmental Impact Assessment is being conducted by the Myanmar Japan Thilawa Development Ltd. (MJTD) through an environmental consultant team, Myanmar Koei International Co., Ltd (MKI). As a part of EIA activities on public consultation, the draft EIA scoping reports had already been disclosed to the public in March, 2020 (for 1-month period between 20th March and 21st April 2020) as specified in attachment 1. Although the public consultation meeting has to be organized during the disclosure period mentioned above, it has temporarily been pending due to COVID 19 pandemic. After the consideration of the possible alternatives to comply with Ministry of Health and Sport (MOHS)'s updated guidelines and specific guideline by Ministry of Natural Resources and Environmental Conservation (MONREC), the public consultation meeting will be organized in order to explain on the projects and the EIA scoping report to the stakeholders and local people and exchange views with participants in terms of environmental and social considerations.
