Main Discussion Points:			
<p><u>Welcoming and opening remarks; Mr. Shimizu (CEO, MJTD)</u></p> <ul style="list-style-type: none">• Mr. Shimizu firstly delivered his Thank You speech to all the attendees from Local Communities. <p>Sharing the updated information of Thilawa SEZ;</p> <p>At this moment, there are more than 90 Investors in TSEZ Zone A and Zone B. 61 Locators have already started their operations and 7700 employees have been employed including local community. Besides, 20 locators out of 90 are still in under construction stage. We expect that more than 8000 employees will be working in TSEZ by the end of this year. Thanks to TSMC One Stop Service Centre and Development Committee surrounding infrastructure, we are still receiving many inquiries from investors. MJTD is planning to develop ZONE B- Phase 3 Constructions within this year and now doing constructions of ZONE B- Phase 2.</p> <p>Mr. Shimizu expressed his apologies to the attendees for the negative impacts such as dust pollution, dropped soil surrounding area which are caused by Constructions and already received complaints to TCMP. TCMP becomes very popular in this community now, is very pleased to be contacted if there are any difficulties among the local communities around TSEZ.</p> <ul style="list-style-type: none">• Discussion and recalled to previous meeting progress by Daw Ai Ai Khaing (Community Relationship Officer/MJTD)<ul style="list-style-type: none">➤ No (2) Basic Education High School (Kyaut Tan) requested the computers and TSEZ had provided (20) computers to the school.➤ We are planning to start school building for Aye Mya Thida Village after consulted with consultants. It was delayed to start because we are consulting with consultants

to manage well at construction sectors for new school building and planning to build a One Storey RC Building (L-180 ft x W-30 ft including 6ft wide corridor) in the near future.

- And for Nyaung Wine Pre School roofs water leaking case, will report and will be considered to donate in 2019 budget year and will support toys for the children too.
- TSEZ will also discuss to donate stationaries and necessities to the students for 2019-2020 Academic Year not only for neighboring villages.
- Even though TSEZ provided very good quality stationaries to 2700 students for 2018-2019 Academic Year, one of the representatives requested to donate a greater number of students because very good quality is not quite important in education. According to that request, TSEZ will consider to provide more stationaries for 2019-2020 Academic Year.

Requested to support the maintenance for remaining roads.
